License for the private import and/or private distribution of spirituous liquors for  
home, medical, scientific and educational purposes

License is hereby granted under and subject to the provisions of the Liquor  
Prohibition Act, section XX, (1920), and the rules, regulations and orders made  
thereunder, to Ernest G. Hume, 217 St. Paul Street, The Ancre, Que.,  
(hereinafter referred to as "the licensee") in payment of a fee of \$2.00,  
authorizing him to buy, transport, possess and use ordinary quantities of spirituous  
liquors referred to as "spirit".

For the purpose of Section 10, paragraph 2, is applied from January 1, 1920  
to December 31, 1920 (both days inclusive) at the premises  
situated at Phenix (hereinafter referred to as  
the licensed premises) subject to the following conditions namely—

Conditions

1. The licensee shall keep all the spirit received by him in a secure place in the  
licensed premises under lock and key and all issues of spirit from the said premises  
shall be made in the presence of the licensee or a person duly authorized by  
him in writing in his behalf. He shall not keep or use spirit in any place other than  
the licensed premises.

2. The spirit received under the license shall not be used except for the purpose  
of Medical — Education.

3. The storage of purchase, production and transport of spirit granted under  
the license shall cease with reference they are incident to its use in accordance with

4. (1) The license shall not continue to apply if (a) from any purchasing  
agent, individual, firm or a total license;

(2) The licensee shall not possess or use spirit of a strength beyond 60° O. F.

5. The licensee shall not obtain the supply of spirit except under a total license  
if such supply does not exceed 6 spirit bottles and firm a separate license if such  
supply exceeds

Provided

his supply of spirit exceeding 6 spirit bottles shall be total license.

6. The licensee shall not use spirit exceeding 5 (Five) quart bottles  
in any one calendar month.

7. The licensee shall not possess at any time spirit in excess of 5 (Five) quart bottles  
in any bottle.

- A. The license shall have the right of export in case of 50 items in premises sufficiently prepared and approved by the municipal or such other authority.
- B. Notwithstanding anything contained in the conditions A. the license may export tobacco and its ordinary derivatives from abroad under the permit issued by the State of Maharashtra if the quantity of the export is to be transported, prepared or sent for sale or even stored till the date this permit incorporates with foreign possession or use and is produced for export (Tobacco) of the State.
- C. All of demerit will be:
10. The license shall be liable to impose a fine of Rs. 10/-
  - The amounts will be kept in a sealed book, signed and stamped with the seal of the Collector/Superintendent of Prisons and Prison.
  - The license holder shall be a licensed medical practitioner, shall maintain a visit book on his practice for use of the Inspector Officer. This book shall be signed and stamped with the seal of the Superintendent of Prisons and Prison.
  - The license may be suspended or canceled in accordance with the provisions of section 31 or 36 of the Bombay Prisons Act, 1947.
  - In case the license is suspended or canceled during the currency of a permit or in case, the whole of the required stock of tobacco in balance with the license shall be finally handed over by him to the officer issuing the license.

Licence is hereby granted, under and subject to the provisions of the Bombay Prohibition Act, 1949 (Bomb. XXV of 1949), and the rules, regulations and orders made thereunder, to Dr. Bipin D. H. Mehta (hereinafter called "the licensee") on payment of a fee Rs. 440/- in advance, authorising him to buy, possess and use rectified spirit including absolute alcohol (hereinafter called "spirit") during the period from 07.04.2014 to 31.03.2015, at his premises situated at Ravet Road, Chembur, (hereinafter referred to as "the licensed premises"), subject to the following conditions, namely:

Conditions

1. The licensee shall not use the spirit for any purpose except for Preparation of chemical Science Projects.
2. (1) The licensee shall not buy spirit except on a requisition countersigned by an Officer of the Prohibition and Excise Department duly authorised in that behalf. Year  
(2) The licensee shall not buy spirit in any quantity exceeding 150 L. P. L. Distilled Methyl Alcohol One hundred fifty only, in the aggregate
3. The licensee shall not have in his possession more than 150 L. P. L. per year. Case packed Fifty only quart bottles of spirit at any one time.
4. The licensee shall keep all the spirit received by him in a place in the licensed premises approved by the Local Inspector of Prohibition and Excise under lock and key and all issues of spirit from the said place shall be made in the presence of the licensee or a person duly authorised by him in writing in that behalf.
5. (1) The licensee shall maintain such accounts as may be prescribed by the Commissioner of Excise and Prohibition under the Act. The account shall be kept in a bound book, page and stamped with the seal of the Collector.  
(2) The licensee shall keep, along with the account book, the requisition and transport passes relating to the spirit received at the licensed premises.  
(3) The licensee shall submit such returns as may be prescribed by the Commissioner of Excise and Prohibition under the Act.  
(4) The licensee shall furnish to the Collector such other information relating to the subject-matter of the licence as the Collector may from time to time require.
6. The licensee shall pay to Government such cost of the Prohibition and Excise staff if it is appointed of Excise and Prohibition for supervision over the use of rectified spirit, as may be fixed by the Commissioner.
7. The licensee premises, the spirit kept therein and the account books, requisition and transport passes referred to in condition 5 and this licence shall at all times be open to inspection by the Collector, or any Prohibition and Excise or Police Officer not lower in rank than a Sub-Inspector of Prohibition and Excise or Police, as the case may be, or by any other officer empowered under section 77(1) of the Bombay Prohibition Act, 1949, who may be deputed or authorised by the Collector or the Superintendent of Prohibition and Excise in this behalf.
8. The accounts, requisitions and transport passes referred to in condition 5 and the licence shall be preserved by the licensee during the whole of the period of this licence.
