Sir,

Ahmednagar Homoeopathic Medical College, Saveli Road, Ahmednagar, Maharashtra-414003 functional since 2017 has submitted an application for permission for sanction of 100 seats in BHMS course for the academic year 23-24. The College has submitted the Part I information in which the entire functional profile has been narrated, MARB has examined the profile of the College as to whether the college fulfills the Minimum Essential Standards as per the prevailing regulations under NCH Act 2020, as per section 29 and subsection (3) of the Act.

As per the observations made by MARB, following information are provided for immediate rectification of the shortfalls. College shall fulfil all functional requirements as per the Minimum Standard Requirements as mentioned below:-

- Copy of Form-16 of the faculties from traces portal shall be submitted for verification.
- Copy of IPD case registers are not submitted in the portal for verification.
- Case records are not submitted against the direction issued from MARB. IPD and OPD case records (copy of one OP and two IP cases of 1st and last day of every month) shall be submitted for verification.
- Case records should be maintained with demographic details of the patient such as name, age, sex, address, phone number etc.
- Case sheets shall be maintained with complete case analysis and evaluation and re-presentation.
- Lab investigation report should be maintained properly in case records.
- All follow up attendance should be recorded in the case records.
- Disease diagnosis shall be recorded in all case records as per ICD-11 criteria.


All the shortfalls observed in your College shall be rectified within a period of 15 days and compliance report shall be submitted to the MARB, failing which the conditional permission issued will be cancelled without further notice.

Considering the above observations, and facilities available, MARB has decided to issue conditional permission to Ahmednagar Homoeopathic Medical College, Saveli Road, Ahmednagar, Maharashtra-414003 for conducting BHMS course for the academic year 2023-24 with intake capacity of 100 seats.

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by Medical Assessment and Rating Board.

- The Continuation / Extension of Affiliation is issued for the Academic Year 2023-2024 subject to the permission of National Commission for Homoeopathy/Central Council of Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi and if the permission is declined by the said authorities this Continuation / Extension of Affiliation shall be treated as cancelled. The college is not authorized to admit the students for 1st year of the course until receipt of permission of the National Commission for Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi.
- The admission shall be done only through the Competent Authorities.
